5. Residential address
6. Note on health treatment
7. Medical examination of an athlete or recreational exerciser

Data is collected for:

1. Records of participants in the event for the purpose of issuing a Certificate of participation in activities
2. Our internal statistical data processing
3. Promotions of new events and programs provided by the Club through its activities
4. Possibilities of sending information, publications, brochures and other advertising material

Your personal information will be treated as confidential information. Only employees will have access to your data, who, given the jobs they perform, should be familiar with them and only to the extent necessary. The legal basis for the processing, ie collection, recording and classification of your personal data is your consent. Giving consent for data processing is voluntary. By doing so, you agree that they be processed, ie. collected, sorted and stored by the Sports Club "Serhispana". In accordance with the provisions of the Law on Personal Data Protection, your personal data will not be used for other purposes, nor will be made available and / or available to third legal or natural persons.

Pursuant to the same Law, you have the right to request additional information related to the processing of your personal data, access to your personal data and their copying, to request correction, addition, update, as well as temporary suspension of processing or deletion of your personal data.
